ICOM Executive Board Elections 2025-2028

Following the call for candidacies, **36 eligible candidates** were nominated for the positions of Ordinary Member and Member of the Bureau. The election process will be overseen by the **Nominations and Election Committee (NEC)**.

The elections will take place at the **27th General Conference** in Dubai (UAE) on 12 and 13 November 2025. The announcement of the election results will take place during the General Assembly meeting on 14 November 2025.

Election of the ICOM Executive Board 2025-2028 Electoral Rules¹

DEFINITION AND COMPOSITION OF THE EXECUTIVE BOARD

The Executive Board is the executive decision-making organ of ICOM and assumes the governing duties of ICOM. It is composed of:

- not less than nine (9) and not more than fifteen (15) elected members
- the Chairperson of the Advisory Council as an *ex officio* member

(Statutes, art. 10, section 1, para. 1)

Two (2) types of mandates are exercised within the ICOM Executive Board:

- the (i) mandate of Ordinary Member of the Executive Board
- the (ii) mandate of Member of the Bureau of the Executive Board, which includes the offices of Treasurer, Vice-Presidents and President. •

(Statutes, art. 10, section 1, para. 2)

DUTIES OF THE EXECUTIVE BOARD

In accordance with Article 10 – Section 4 of the ICOM Statutes, "The Executive Board is the elected head of the Organisation vested with the responsibility of overseeing the implementation by the relevant organs and bodies of the strategies identified by the General Assembly and taking the necessary measures to implement the General Assembly's decisions.

The Executive Board shall ensure the good management of ICOM,

and shall oversee ICOM's various resources (financial, material, human, intellectual and technical), their use, disposal and development. It shall, in particular, approve the annual accounts of ICOM. It shall undertake to protect ICOM's reputation, international esteem and public regard and shall provide direction to the Secretariat.

It shall recommend the amount for the membership fees that shall be subject to the approval of the Ordinary General Assembly.

The Members of the Executive Board shall exercise their mandate diligently and lovally in the interest of ICOM. They shall act within the limits of the powers ascribed to them by the statutory and regulatory texts of ICOM, the decisions taken by the General Assembly, the Executive Board itself, the Strategic Plan, the provisional budget and the law. They shall devote the necessary time and attention to the tasks and duties of the Executive Board. They shall not exceed their duties, act outside the scope of the Organisation, cause damage to the Organisation or act with negligence or imprudence".

ICOM EXECUTIVE BOARD CODE OF CONDUCT

In accordance with Article 10 – Section 4 of the ICOM Statutes, "Members of the Executive Board shall respect and implement the Code of Conduct established by the Executive Board and ratified by the Ordinary General Assembly".

To enable ICOM to achieve its aims and purposes, ICOM requires best practice in governance and the highest standards of ethical behaviour from its elected representatives. Following an internal review, the ICOM Executive Board developed a code of conduct in compliance with the ICOM Statutes, Internal Rules, Code of Ethics for Museums and core values (hereinafter the "Code of Conduct"). It sets out the principles and practices that will guide the ICOM Executive Board to maintain the high standards of leadership and governance required by the association. Before its formal adoption, the Executive Board submitted the Code of Conduct to the Standing Committees on Legal Affairs (LEAC), the ICOM Ethics Committee (ETHCOM) and to all National Committees, International Committees and Regional Alliances for their consideration and comments, which were eventually reflected in the final version. The Code of Conduct was then adopted by the Executive Board at its 155th Session (20 - 21 May 2021) for a 16-month pilot phase and ultimately approved by the 37th Ordinary General Assembly held on 24 August 2022.

NOMINATION AND ELIGIBILITY

Nominations

(Internal Rules, art. 3.2.1, para. 1)

The National Committees (NCs), International Committees (ICs) and Regional Alliances (RAs) can nominate candidates for election as Members of the Executive Board.

Eligibility

(Internal Rules, art. 3.2.2, para. 1)

NCs/ICs/RAs may nominate any individual member in good standing as a candidate for the election of the Executive Board. The nominated need not be a member of the nominating NC/IC/RA.

Ineligibility

(Internal Rules, art. 3.2.2 and Statutes Article 6 - Sections 4 and 5, and Article 10 - Section 2)

The following individuals are ineligible for membership to the Executive Board:

- designated representatives of institutional members,
- employees² of ICOM or its Committees,
- former employees of ICOM or its Committees, who shall be ineligible for a period of two (2) years after the expiry or termination of their contract. This requirement shall be met on the 31st of December of the year preceding the Executive Board election,

Note: for the elections in 2025, the relevant date for the end of the contract is 31 December 2022.

• the Student, Honorary and Supporting Members.

Term of office

(Statutes, art. 10, section 2)

• The members of the Executive Board shall be elected by the Ordinary General Assembly for a three (3) year term of office under

the conditions laid down in the Statutes and the Internal Rules.

- Members elected to the position of Ordinary Member may not serve more than two (2) mandates as Ordinary Member.
- Members elected to the position of Bureau Member may not serve more than two (2) mandates as a Bureau Member.
- No person shall be permitted to serve more than four (4) mandates, i.e. two (2) mandates as Ordinary Member and two (2) mandates as Bureau Member. The ex officio capacity of the Chairperson of the Advisory Council shall be considered as an Ordinary Member of the Executive Board

Non-accumulation of offices

In accordance with Article 10 - Section 2 of the ICOM Statutes, "Persons elected to the Executive Board shall not be permitted to hold additional offices within ICOM, unless they have been authorised to do so by the Executive Board". In accordance with Article 6.4 of the ICOM Internal Rules, "The Chair of a National Committee may not at the same time serve as a [...] member of the Executive Board". In accordance with Article 7.4 of the ICOM Internal Rules, "The Chair of an International Committee may not at the same time serve as a [...] member of the Executive Board".

CANDIDACY APPLICATION

Application

(Internal Rules, art. 3.2.1, para. 1)

A candidate can apply for a single function only in the Executive Board.

Forms

(Internal Rules, art. 3.2.1, para. 2-3) The candidacy forms presented by the NCs and/or ICs and/or RAs must:

- contain the name of the NC/IC/RA that is nominating the candidate,
- include a biographical profile of the latter,
- be signed by the candidate,
- be signed by the Chair of the NC/ IC/RA and by another Member of the NC/IC/RA's Board,

Note: a candidate may not sign his/ her own nomination form as one of the two Board members, self nomination is prohibited.

· be sent to the Secretariat,

in accordance with the election procedure rules using the established forms provided by the Secretariat.

Calendar

(Internal Rules, art. 3.2.3, para. 1)

The candidacy forms must be filed by the designated deadline, which is set by the Secretariat in accordance with an elections calendar adopted by the Executive Board. This calendar must be provided to the NCs/ICs/RAs within one (1) month of its adoption.

For the elections of the 2025-2028 Executive Board, the elections calendar was approved by the Executive Board at its 172nd Session (10 June 2024) and made available to members on 10 July 2024. 16 December 2024 was the deadline for the submission of candidacies.

Procedure

(Internal Rules, art 3.2.3, paras. 2-3 and art. 3.2.4, paras. 1-2)

- The candidacies must be addressed to the Secretariat.
- The Director General examines the candidacy applications and has them completed where necessary,
- The applications are forwarded to the Nominations and Election Committee (NEC)³, which must validate the admissibility of candidacies within no more than 3 months following the filing deadline.
- Upon expiry of the specified time limit to correct the candidacy application, the NEC validates the nomination of candidates and authorises the Secretariat to publish a list of candidates for ordinary membership on the Executive Board and for each Bureau position.

PRESENTATION OF THE CANDIDATES

- Candidates may not solicit the Secretariat to promote their candidacy. In accordance with Article 3.2.5 of the Internal Rules, and in addition to the brochure of candidates, "the candidates are free to promote their candidacy within ICOM in additional ways".
- A candidate presentation document is published in ICOM's three (3) official languages and communicated to ICOM's members, no later than three (3) months prior to the date of commencement of the General Conference.
- This document shall contain a presentation of each candidate's name, biographical data and vision,

- and a description of the election process.
- The candidates are free to promote their candidacy within ICOM in additional ways. (Internal Rules, art. 3.2.5)

VOTING PROCESS

Voting

In accordance with Article 3.2.6 of the ICOM Internal Rules, "(...) Voting rights are set forth in the Statutes Article 7 (...). Each National and International Committee has the right to appoint five (5) Members to vote on its behalf. Each Regional Alliance has the right to appoint three (3) and each Affiliated Organisation has the right to appoint two (2) Members to vote on its behalf".

Elections for the Executive Board 2025-2028 will take place at the 27th General Conference in Dubai (United Arab Emirates), in November 2025.

As per the terms of Article 3.2.6 of the ICOM Internal Rules, "Electoral rules reiterating and specifying these guidelines shall be drawn up by the Director General and validated by the Nominations and Election Committee for each election".

The Nominations and Election Committee (NEC) approved the use of an online voting system, recognising the significant logistical advantages it offers compared to traditional paperbased methods.

Proxy

(Internal Rules, art. 3.2.6, paras. 3-4 and Statutes art. 7, sections 1 and 2)

- Voting Members who are unable to be present on the days of voting may choose to vote by proxy, whereby they may designate another voting Member to vote on their behalf.
- Only proxy forms created by the ICOM Secretariat shall be accepted at the time of voting.
- Upon presentation of the proxy, the Voting Member shall receive the voting ballot of the Member he/she is representing.
- Maximum proxies by voting member:
 - a Voting Member designated by a NC or an IC shall not be entitled to more than five (5) proxies,
 - a Voting Member designated by an RA shall not be entitled to more than three (3) proxies,
 - a Voting Member designated by an AO shall not be entitled to more than two (2) proxies.

Voting ballot

(Internal Rules, art. 3.2.6, paras. 5-6, 11)

- On the voting ballot paper received, the voting member will have to tick a maximum of:
 - 1 box for the President,
 - 2 boxes for the Vice-Presidents,
 - 1 box for the Treasurer,
 - 11 boxes for the Ordinary Board Members.

If more boxes are ticked, the voting ballot shall be deemed invalid.

• The voting ballot system may be replaced by any technical means rendering it possible to use an electronic voting or remote voting system, which is recommended by the NEC and the Secretariat (Internal Rules, art. 3.2.6, para. 11).

Voting stations

(Internal Rules, art. 3.2.6, para. 7)

Voting Members may enter voting stations for a maximum period of two (2) consecutive days.

RESULTS

Decision by the largest number

- Candidates to an Ordinary Member position within the Executive Board that obtain the largest number of votes shall be elected (*Internal Rules, art. 3.2.6, para. 8*).
- The same shall apply with regard to Members seeking a seat in the Bureau (*Internal Rules*, art. 3.2.6, para. 9).

Electoral tie

If two (2) candidates receive an equal number of votes, the final selection shall be made as follows, under the scope of Article 3.2.4 of the ICOM Internal Rules:

- As a prerequisite, candidates with an equal number of votes are advised to consider stepping down to allow the other candidate to take up the position.
- In the event that no candidate agrees to step down, the following rule shall apply: in the event of an equal number of votes for two or more candidates, the oldest candidate shall be deemed elected.

Announcement of the results and start of the term of office

- The NEC shall validate the results of the election to the Executive Board (Internal Rules, art. 3.2.4, para. 1).
- The election of the 11 Members to the Executive Board shall have

- taken place when the result of the voting is announced during the General Assembly meeting held during the General Conference (Internal Rules, art. 3.2.6, para. 1).
- The election of the Executive Board Members is effective from the close of the General Assembly meeting during which elections were held (*Internal Rules, art. 3.2.6, para. 12*).

Affiliated Organisations should be seen as a full part of ICOM, they have their own capabilities and may both strengthen ICOM and be strengthened by it.

We proved this with CIMAM through the Museum Watch Governance Management Project with INTERCOM. At present, CIMAM has a new cooperation with five ICOM committees, on the topic of respect for artists. This focus of contemporary art museums may be a signal for a wider quest. A museum is essentially horizontal if it understands itself through equal relations with its outside.

The same kind of qualitative, generative equality seems to me also key to the future of ICOM.

All the very diverse topics of museums have an equal potential of depth. Museums naturally tend to partner with museums with which they feel connected. Inspiration, on the contrary, may come from encounters with approaches very divergent from one's own.

Scale differences too may lead to this. Today, bigger is not necessarily considered better anymore. It also means more complex systems, and loss of proximity. Small museums have a higher capacity to be vital and immediate.

As a board member I want to do anything that is needed to serve ICOM and you, but always with equivalent relations between very diverse members as a core point of attention.

ICOM Statutes

ICOM Statutes, Article 10. Executive Board

Section 1 - Organisation

The Executive Board is the executive decision-making organ of ICOM and assumes the governing duties of ICOM. It consists of not less than nine (9) and not more than fifteen (15) elected members, as well as the Chairperson of the Advisory Council as an ex officio member.

Two (2) types of mandates are exercised within the ICOM Executive Board: (i) the mandate of Ordinary Member of the Executive Board, and the (ii) mandate of Member of the Bureau of the Executive Board, which includes the offices of Treasurer, Vice-Presidents and President.

Section 2 - Elections

The members of the Executive Board shall be elected by the Ordinary General Assembly for a three (3) year term of office under the conditions laid down in the Statutes and the Internal Rules.

Members elected to the position of Ordinary Member may not serve more than two (2) mandates as Ordinary Member.

Members elected to the position of Bureau Member may not serve more than two (2) mandates as a Bureau Member.

No person shall be permitted to serve more than four (4) mandates, i.e. two (2) mandates as Ordinary Member and two (2) mandates as Bureau Member. The ex officio capacity of the Chairperson of the Advisory Council shall be considered as an Ordinary Member of the Executive Board.

Only Individual Members in good standing shall be entitled to be elected to the Executive Board.

Persons elected to the Executive Board shall not be permitted to hold additional offices within ICOM, unless they have been authorised to do so by the Executive Board.

Section 3 – Meetings

The Executive Board shall meet in ordinary session at least four (4) times a year and as often as deemed necessary. One (1) of these meetings shall be held prior to any General Assembly in order to coordinate with the President of ICOM the modalities of that General Assembly.

Decisions taken by the Executive Board shall be made available to ICOM Members.

Section 4 – Duties of the Executive Board

The Executive Board is the elected head of the Organisation vested with the responsibility of overseeing the implementation by the relevant organs and bodies of the strategies identified by the General Assembly and taking the necessary measures to implement the General Assembly's decisions.

The Executive Board shall ensure the good management of ICOM, and shall oversee ICOM's various resources (financial, material, human, intellectual and technical), their use, disposal and development. It shall, in particular, approve the annual accounts of ICOM. It shall undertake to protect ICOM's reputation, international esteem and public regard and shall provide direction to the Secretariat.

It shall recommend the amount for the membership fees that shall be subject to the approval of the Ordinary General Assembly.

The Members of the Executive Board shall exercise their mandate diligently and loyally in the interest of ICOM. They shall act within the limits of the powers ascribed to them by the statutory and regulatory texts of ICOM, the decisions taken by the General Assembly the Executive Board itself, the Strategic Plan, the provisional budget and the law. They shall devote the necessary time and attention to the tasks and duties of the Executive Board. They shall not exceed their duties, act outside the scope of the Organisation, cause damage to the Organisation or act with negligence or imprudence.

Members of the Executive Board shall respect and implement the Code of Conduct established by the Executive Board and ratified by the Ordinary General Assembly.

Section 5 – Quorum and Decisions

The quorum of participation for an Executive Board meeting shall be constituted when more than fifty percent (50%) of the Members are present and/or represented.

Each Executive Board Member, including the Chairperson of the Advisory Council, shall be entitled to one (1) vote. In the event of a deadlock, the President of ICOM shall be entitled to exercise a casting vote.

All decisions of the Executive Board are taken by a simple majority between the Members present and represented.

Section 6 - The Bureau

The Bureau of the Executive Board consists of:

- the (1) President;
- the two (2) Vice-Presidents;
- the (1) Treasurer.

The President shall be entitled to address urgent issues and to provide ad hoc solutions in co-operation with the Bureau. The Bureau meets whenever necessary, when convened by the President or at the request of two (2) of the Bureau Members.

It shall take decisions by simple majority.

Such actions shall be reported to the Executive Board at the earliest opportunity with an explanation of the emergency and the subsequent action.

Section 7 – The President

The President shall be elected by the triennial General Assembly for a three (3) year term of office. He/she may be re-elected within the limits of the mandates and eligibility criteria laid down in the Statutes and the Internal Rules.

The President:

- is responsible for monitoring and ensuring the proper implementation of the guidelines, policies and decisions taken by the Executive Board or the General Assembly;
- participates in the definition of the Organisation's projects and strategy (actions to be implemented, financing, etc.):
- represents the Organisation within the scope of all civil acts;
- represents the Organisation with its associative, private and institutional partners as well as with public authorities:
- binds ICOM by his/her signature in agreements with third parties;
- -communicates on behalf of the Organisation with the public, the press, the media and with the Members;
- orders expenses;
- can delegate his/her powers within the conditions provided by the Internal Rules;
- works in close collaboration with all organs and bodies of ICOM as well as with third parties;
- delegates all or part of its operational attributes and/or authority to the Director-General to manage ICOM's day-to-day operations;
- ensures the well-functioning of the Organisation (administration,

logistics, human and financial resources);

- ensures, as the Director General's superior, that he/she implements the decisions taken by the President, the Executive Board and the General Assembly.

Within the Executive Board, the President:

- convenes meetings of the Executive Board on his/her decision, or at the request of one-third (1/3) of the Executive Board;
- sets the agenda;
- chairs and leads debates;
- warns the Executive Board of critical situations for the Organisation and proposes an action plan drawn up with the parties concerned;
- sets with the Executive Board the modalities for the implementation of the strategic orientation pertaining to ICOM's activities in its capacity as an international organisation representing museums and museum professionals, in accordance with the strategies decided by the General Assembly.

For General Assemblies, the President:

- convenes the General Assemblies in accordance with the conditions set by the Statutes;
- ensures the good preparation, organisation and running of General Assemblies:
- supervises the redaction of the annual report with the Secretariat and presents it to the General Assembly for approval;
- presides, leads and facilitates the debates:
- ensures the smooth running of the General Assembly and ensures that

the agenda is respected.

Section 8 – The Vice-Presidents

The two (2) Vice-Presidents shall be elected by the triennial General Assembly for a three (3) year term of office. They may be re-elected within the limits of the mandates and eligibility criteria laid down in the Statutes and the Internal Rules.

The Vice-Presidents:

- assist the President in carrying out his/her duties;
- support the President in representing ICOM and promoting its objectives and activities worldwide:
- carry out the duties and tasks assigned to them by the President;
- replace the President in his/her absence or if he/she is unable to perform his/her duties;
- convene and chair meetings in the absence of the President;
- ensure the application and implementation of the various decisions taken by the ICOM organs and bodies:
- may provide assistance to the President in resolving issues at General Assemblies:
- ensure the monitoring of Treasury with the Treasurer and the President.

Section 9 – The Treasurer

The Treasurer shall be elected by the triennial General Assembly for a three (3) year term of office. He/she may be re-elected within the limits of the mandates and eligibility criteria laid down in the Statutes and the Internal Rules.

The Treasurer:

- is responsible for monitoring the financial policy adopted, the transparency and proper functioning of the financial and accounting system, and the financial capacity of the Organisation;
- participates in the definition of the Organisation's projects and their financing;
- works in close collaboration with stakeholders (ICOM organs and bodies, Standing Committees, Working Groups, auditor of accounts, banks, third parties to ICOM, etc.);
- makes proposals and ensures the implementation and use of management tools necessary for the performance of its mission (filing, archives, monitoring tools, etc.).

With regard to accounts, the Treasurer:

- analyses the Treasury plan and the financial data of the Organisation;
- ensures that the Organisation's accounts are properly kept;
- reviews the financial statements prepared by the Finance Department;
- follows the treasury plan.

With regards to budget, the Treasurer:

- participates in the preparation of the budget and budget estimates with the relevant stakeholders and in accordance with the decisions adopted by the ICOM organs and bodies;
- regularly reviews the financial forecasts and budgets;
- controls the financial flows:
- monitors and maintains financial inflows such as memberships, donations, dues and grants;
- optimises financial processes;

- participates in the preparation and monitoring of grant applications with the relevant stakeholders, including the budget allocated for each activity.

Within the Executive Board, the Treasurer:

- reports and presents regularly to the Executive Board the budget and any other financial matters of the Organisation (available funds, expenses to be incurred, etc.);
- warns the Executive Board on critical financial situations and presents an action plan established with the relevant stakeholders.

For General Assemblies, the Treasurer:

- prepares, together with the ICOM Finance Department and the auditor, the financial statements and the management report for the financial year ('annual financial report') and presents it to the General Assembly for approval and discharge;
- prepares the provisional budget for the following financial year (N+1) in accordance with the objectives and decisions of the Organisation in the short, medium and long term, and presents it to the General Assembly for information;
- may provide assistance to the President in his/her field of expertise;
- addresses the financial and accounting issues raised by the General Assembly.

Section 10 – Vacancy

In case of vacancy of the President's office for any reason whatsoever (impeachment, resignation, unavailability for more than three (3) months), the Executive Board shall appoint within fifteen (15) days one

(1) of the Vice-Presidents to assume the presidency for the remainder of the term of office.

In case of vacancy of the office of Vice-President for any reason whatsoever (impeachment, resignation, unavailability for more than three (3) months), the Executive Board shall appoint an Ordinary Member to assume this function for the remainder of the term of office.

In case of vacancy of the Treasurer office for any reason whatsoever (impeachment, resignation, unavailability for more than three (3) months), the Executive Board shall appoint an Ordinary Member to assume this function for the remainder of the term of office.

If an Ordinary Member is called upon to serve as a Bureau Member due to a vacancy, the mandate exercised during the term of office shall be deemed to be a mandate of an Ordinary Member.

In case of vacancy of the position of an Ordinary Board member for any reason whatsoever (impeachment, resignation, unavailability for more than three (3) months), the position shall remain vacant until the following election is held by the General Assembly. However, if the Executive Board is composed of less than seven (7) members, an Ordinary General Assembly shall be convened as soon as possible in order to appoint a sufficient number of members of the Executive Board to respect the minimum number of members provided for by the Statutes.

ICOM Internal Rules, Article 3.2 Election to the Executive Board

3.2.1 Candidacy Forms

The National and International Committees, and Regional Alliances can nominate candidates for election as Members of the Executive Board. A candidate can apply for a single function only.

The candidacy forms presented by the National and/or International Committees and/or Regional Alliances must be sent to the ICOM Secretariat in accordance with the election procedure rules using the established forms provided by the ICOM Secretariat.

Each form must contain the name of the Committee and/or Regional Alliance that is nominating the candidate and must include a biographical profile of the latter, signed by the Chair of the National and/or International Committee and/or Regional Alliance and by another Member of the Committee's or Regional Alliance's Board.

3.2.2 Eligibilities and Ineligibilities

National and International Committees and Regional Alliances may nominate any individual member in good standing for membership to the Executive Board. The nominated need not be a member of the nominating Committee or Regional Alliance.

The following individuals are ineligible for membership to the Executive Board:

- designated representatives of institutional members;
- employees of ICOM or its Committees;

- former employees of ICOM or its Committees, who shall be ineligible for a period of two (2) years after the expiry or termination of their contract. This requirement shall be met on the 31st of December of the year preceding the Executive Board election.

"Employee" refers to each individual who carries out functions for ICOM or its Committees and receives remuneration for these functions.

3.2.3 Candidacy Application

Candidacy forms must be filed by the designated deadline, which is set by the ICOM Secretariat in accordance with an elections calendar adopted by the Executive Board. This calendar must be provided to the Committees and Regional Alliances within one (1) month of its adoption.

Candidacies must be addressed to the ICOM Secretariat. Once the Director General has examined the candidacy applications and have them completed where necessary, the applications are subsequently forwarded to the Nominations and Election Committee which must validate the admissibility of candidacies within no more than three (3) months following the filing deadline.

In the case where a candidacy is deemed inadmissible by the Nominations and Election Committee, a decision to that effect must be communicated to the National or International Committee or Regional Alliance that put the candidacy forward, granting them the opportunity to correct the candidacy application within a specified time.

3.2.4 The Nominations and Election Committee

The Nominations and Election Committee (NEC) shall ensure that the nomination and election process is carried out as described in the Statutes and the Internal Rules and shall validate the nomination of candidates and the results of the election to the Executive Board.

Upon expiry of the specified time limit to correct the candidacy application, the Nominations and Election Committee authorises the ICOM Secretariat to publish a list of candidates for ordinary membership on the Executive Board and for each Bureau position.

During the nomination and election process, *ad hoc* situations may occur, which makes it necessary for the Nominations and Election Committee to decide what the appropriate procedure is and implement it.

Within three (3) months after the end of each completed nomination and election process, the chair submits a report to the Chair of the Advisory Council. The report may include recommendations. The Nominations and Election Committee's recommendations and decisions must have been adopted by a simple majority of the Committee's members.

The Nominations and Election Committee is comprised of five (5) to nine (9) ICOM Members who are not candidates for membership of the Executive Board. They are nominated by the Chair of the Advisory Council and appointed by the Advisory Council. The chair and ordinary members of the Nominations and Election Committee can serve two (2) consecutive terms in each position, with a maximum consecutive serving time of four (4) terms. A term covers the time needed for one complete nomination and election process.

The Nominations and Election Committee is presided over by its Chair, and reports to the Chair of the Advisory Council. The Director General can take part in the meetings but shall not take part to the votes. The Nominations and Election Committee is assisted by the relevant professionals(s) in the Secretariat.

3.2.5 Presentation of Candidates

A candidate presentation document is published in ICOM's three (3) official languages and communicated to ICOM's members, no later than three (3) months prior to the date of commencement of the General Conference. This document shall contain a presentation of each candidate's name, biographical data and vision, and a description of the election process.

The candidates are free to promote their candidacy within ICOM in additional ways.

3.2.6 Election of Members to the Executive Board

The election of Members to the Executive Board shall have taken place when the result of the voting is announced during the General Assembly meeting held during the General Conference. Voting rights are set forth in the Statutes Article 7.

Each National and International Committee has the right to appoint five (5) Members to vote on its behalf. Each Regional Alliance has the right to appoint three (3) and each Affiliated Organisation has the right to appoint two (2) Members to vote on its behalf.

Voting Members who are unable to be present on the days of voting may choose to vote by proxy, whereby they may designate another voting Member to vote on their behalf.

Only proxy forms created by the ICOM Secretariat shall be accepted at the time of voting. Upon presentation of the proxy, the Voting Member shall receive the voting ballot of the Member he/she is representing.

In order to be valid, a vote must provide the option to select, by ticking a box, a maximum of eleven (11) candidates for ordinary membership on the Executive Board. If this condition is not satisfied, the voting ballot shall be deemed invalid.

In addition, for each Bureau position the voting ballot must provide the option to select, by ticking a box, no more than a single (1) candidate. If this condition is not satisfied, the vote for the relevant seat in the Bureau shall be deemed invalid. Voting Members may enter voting stations for a maximum period of two (2) consecutive days.

Candidates to an Ordinary Member position within the Executive Board that obtain the largest number of votes shall be elected.

The same shall apply with regard to Members seeking a seat in the Bureau.

Electoral rules reiterating and specifying these guidelines shall be drawn up by the Director General and validated by the Nominations and Election Committee for each election.

The voting ballot system may be replaced by any technical means rendering it possible to use an electronic voting or remote voting system, which is recommended by the Nominations and Election Committee and the ICOM Secretariat.

The election of the Executive Board Members is effective from the close of the General Assembly meeting during which elections were held.
